In consideration of the acceptance of my application for entry in any or all Fat Tire Bike Week events, I hereby freely agree to & make the following contractual representation & agreements. I fully realize the dangers of participating in all types of cycling and cycling related activities, including mountain biking, & fully assume the risks associated with such participation including, by way of example, & not limitations, the following: The dangers of collision with pedestrians, vehicles, other riders & fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment & weather conditions; & the possibility of serious physical &/or mental trauma associated with the sport of cycling / mountain biking.

I hereby waive, release & discharge for myself, my heirs, executors, administrators, legal representatives, assigns & successors in interest (hereinafter collectively "successors") any & all rights & claims which I have or which I may hereafter occur to me against the sponsors of this event, the volunteers and employees of this event, all spectators, Crested Butte Mountain Bike Association (CBMBA) and its members, the exhibitors and vendors of this event, The Crested Butte/ Mt. Crested Butte Chamber of Commerce and its employees, The Crested Butte / Mt. Crested Butte Visitors' Centers and its employees, The Town of Crested Butte, The Town of Mt. Crested Butte, Gunnison County, the US Forest Service, property owners, law enforcement agencies, all public entities, special districts & properties (& their respective agents, officials, employees) through or by which the events will be held for any & all damages which may be sustained by me or my property directly or indirectly in connection with or arising out of my participation in or association with the event or travel to or return from the event.

I agree for myself & successors that the above representations are contractually binding & are not mere recitals & that should I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally judged liable on such claim for willful & wanton negligence. This agreement may not be modified orally, & a waiver of any provision shall not be construed as a modification of any other provisions herein or as a consent to any other provision herein or as a consent to any subsequent waiver or modification.
